



ONLINE PAYMENT INSTRUCTIONS

Note: Setting up accounts to make payments is not required, but will make things easier in the future should you choose to do so.

Tax Return Payments

FEDERAL

To make your Federal tax payment, please either create an account at <https://www.irs.gov/payments/online-account-for-individuals>, or visit <https://www.irs.gov/payments> to make an online payment without setting up an account.

When completing the payment form, select the following options in this order:

- **Reason for Payment:** Balance Due
- **Apply Payment To:** Income Tax – Form 1040
- **Tax Period for Payment:** 2025
- **Then follow the verification steps using prior tax information.**

OREGON

To make your Oregon tax payment, visit the Oregon Department of Revenue at <https://revenueonline.dor.oregon.gov/> to create an account, or to make an online payment without setting up an account.

On the homepage, scroll down to Quick Links and select “Make a payment”. Choose your preferred payment method, and input your personal information to “Login”. If asked whether you received a notice letter with a payment voucher, select “No.”

When prompted in the Account Information tab, select the following options in this order:

- **Account Type:** Personal Income Tax
- **Payment Type:** Return Payment
- **Filing Frequency:** Annual
- **Tax Year:** 2025

Estimated Payments

FEDERAL

To make your Federal estimated tax payment, please either create an account, or visit <https://www.irs.gov/payments> to make an online payment without setting up an account.

- **Reason for Payment:** Estimated Tax
- **Apply Payment To:** 1040ES
- **Tax Period for Payment:** 2026
- **Then follow the verification steps using prior tax information.**

OREGON

To make your Oregon estimated tax payment, visit the Oregon Department of Revenue website: <https://revenueonline.dor.oregon.gov/> to create an account, or to make an online payment without setting up an account.

On the homepage, scroll down to Quick Links and select “Make a payment.”

- **Account Type:** Personal Income Tax
- **Payment Type:** Estimated Payment
- **Filing Frequency:** Annual
- **Tax Year:** 2026
